How to use:

Dilute product as indicted here below in a bucket of warm water. Proceed to clean surface using a standard wet mop system. Mop evenly to remove all surface dirt, grime and dust. No rinse required. Allow to dry.

Worktops:

Dilute product as indicated and apply to surface by spraying product direct on surface. Allow a few minutes before wiping off with clean cloth.
