	NO RISALITA is a water based, protective treatment specific for the application to the back side of floor or wall tiles and materials. Product avoid potential staining and marking caused by eventual rising humidity and moisture contained inside cement bedding or adhesive mixture.			
	Treatment is highly recommended for all materials that suffer problems and marking due to underfloor humidity and moisture. Product will block the appearance of oxidation, staining, pitting and water marks or eventual salts and efflorescence from forming on surface. Product can be applied to the back side or to sides of tile in contact with cement based adhesive and will not affect bonding and adhesion.			
NO RISALITA is colorless and is applicable to all stone surfaces. Highly recommended on white marbles and in cases where a low quality adhesive or a simple cement/sand/mortar mix is used for fixing.				
How to use:	Always test first before proceeding with complete product application so to determine product compatibility and final result on material. Protect and cover all surroundings and metallic fixings using PVC sheeting and tape. Wear suitable PPE equipment during product use (gloves, eye protection and clothing). Do not apply where temperatures are below 10°C.			
	Best applied during a dry lay process.			
	<div><div>1.</div><div>During a dry lay process, apply NO RISALITA by using a roller, large bristle brush or spray uniformly to the underside and sides of tile or material.</div></div> <div><div>2.</div><div>Allow a curing time of 6 hours before proceeding with installation.</div></div> <div><div>3.</div><div>On compact surfaces, product can be used diluted following a ratio of 1:9 with water.</div></div>
