	resistant, will not leave surface film or residues and will maintain the natural colour and finish of material. ZEUS can be applied to all polished and non-polished stone surfaces such as marbles, granites, limestone's, quartzite's, terrazzo, terracotta, cement, agglomerates and much more.
How to use :	Always test first before proceeding with complete product application so to determine product compatibility and final result on material. Protect and cover all surroundings and metallic fixings using PVC sheeting and tape. Wear suitable PPE equipment during product use (gloves, eye protection and clothing). Product is ready for use. Do not apply where temperatures are below 10°C
	Always apply to clean, dry and dust free surfaces.
	Polished surfaces: 1. Apply one coat ZEUS uniformly by low pressure spray, cotton cloth or soft bristle brush. Allow contact time of 5/10 minutes so to allow a complete penetration into material before removing excess product using a clean cotton cloth. 2. After approximately 1 hour, remove eventual residues using a white felt pad. 3. Allow a complete curing time of surface for 72 hours for complete surface protection.
	 Honed and textured surfaces: Apply one coat ZEUS uniformly by low pressure spray or brush. Allow contact time of 5/10 minutes so to allow a complete penetration into material. On very absorbent surfaces, proceed to apply a second coat before removing excess product using a clean cotton cloth or lambswool applicator. Allow a complete curing time of surface for 72 hours for complete surface protection.
Maintenance:	Surfaces treated with ZEUS are compatible with ph ne utral deter gents. Please refer to the below products for cleaning of treated surface. (please refer to product TDS for full product use and instructions:
